## 1. Overview

Health Research BC invites BC-based researchers and eligible health system staff<sup>1</sup> to apply for the Engage Awards. The purpose of the Engage Awards is to support researchers and research users to explore how they can work together to advance research and the use of research evidence to address challenges in Health Research BC's priority themes.

### Objectives

The objectives of the Engage Award are to:

- support the creation and development of mutually beneficial relationships between researchers and research users;
- enable mutual understanding of challenges and/or research priorities within the Health Research BC priority themes; and
- support researchers, trainees, and research users to build engagement skills.

Health Research BC intends to support applications from across BC (see [Funding Pools](#)).

### Focus and design of events/activities

The Engage Awards will support relationship building events/activities in order to:

- form new connections or relationships between researchers and research users;
- strengthen existing connections or relationships between researchers and research users; and
- support researchers and research users to explore the potential for collaborative production of research and mobilizing research evidence into practice, policy, and the public sphere.

The events/activities must focus on a topic related to at least one of Health Research BC's [four priority themes](#) and must be collaboratively planned to ensure mutual benefit for both researchers<sup>2</sup> and research users<sup>3</sup>.

The design of the events/activities should integrate culturally safe practices that demonstrate humility, integrity, and accountability. Applications involving Indigenous peoples must abide by Health Research BC policies on [Responsible conduct of Indigenous health research](#). All applications must include [EDI considerations](#) as appropriate to the context of the work. Where

<sup>2</sup> For the purpose of this competition, a researcher is an individual with a research appointment at a BC-based host institution; see [Who Can Apply](#) for more details.

<sup>3</sup> Research users are individuals who might use, benefit or be impacted by the results of research. Research users may or may not be involved in the production of research results. Research users include, but are not limited to, people with lived experience policymakers, health professionals, decision makers, educators, community leaders, etc. Research users may also be other researchers, however for the purposes of this competition, researchers may not apply in the role of research user co-lead.

feasible and appropriate, Health Research BC encourages the inclusion of [people with lived experience \(PWLE\)](#) and community members<sup>4</sup>.

### Examples of events/activities not supported

The Engage Award does not support:

- operating funds for research (e.g., data gathering, data analysis).
- dissemination knowledge mobilization (KM) activities (e.g., presentation at a conference, preparation and distribution of a report).
- activities intended for outreach or the broad engagement of audiences such as conferences, workshops, annual series, and public engagement events. Small “satellite” meetings that are focused on relationship development but leverage larger events such as conferences may be eligible.

## 2. Award Amount, Duration and Timeline

The Engage Award offers up to \$5,000 over four months (see [Allowable Expenses and Example Budget](#)). Events/activities must be initiated August 1, 2026, with completion planned no later than November 30, 2026. Should unexpected delays occur, funds may be spent for up to six months after the start date without the need to request a no-cost extension. No further no-cost extensions will be permitted. Any funds not spent within the six months must be returned to Health Research BC.

The funding envelope for the Engage Awards is \$250,000, enough to fund up to 50 awards. Health Research BC intends to support applications from across BC (for more details see [Funding Pools](#) and [Funding Decisions](#)).

## 3. Who Can Apply

All applications require a Primary Applicant and a Co-lead. The **Primary Applicant** must be a BC-based researcher or eligible health system staff. The Primary Applicant will be responsible

for completing and submitting the application form, implementing the events/activities, and managing the award funds. The application must be collaboratively planned with a **Co-lead** who must be named in the application. We encourage Co-leads to be involved in the planning and/or implementation of the proposed events/activities; however the level and type of involvement of the Co-lead should be appropriate considering their expertise and the context.

If you are **Health System Staff**, you may apply as a **Primary Applicant** if you:

- are affiliated with an eligible host institution that has signed a Memorandum of Understanding (MOU) with Health Research BC ([Appendix A](#)); and are in a position that allows you to apply for and hold research operating funds (see Table 2).

*Note: If you are uncertain about whether your position allows you to hold research operating funds, we strongly recommend that you seek your manager's approval before proceeding with an application.*

- identify a researcher co-lead (see Table 2).
  - The researcher co-lead can be any of the following: researchers with a faculty position (e.g., assistant professor, adjunct professor), postdoctoral fellows, clinical research fellows, research associates, and researchers associated with Indigenous communities and organizations (ICO)<sup>5</sup>, Elders, and knowledge keepers.

If you are a **Researcher**, you may apply as a **Primary Applicant** if you:

- are affiliated with a host institution that has signed a MOU with Health Research BC (link to list of eligible host institutions), and hold a position that allows you to apply for and hold research operating funds.
- identify a research user co-lead (see Table 2).
  - Research user co-leads may include collaborators from not-for-profit, public or private sector organizations, such as practicing health professionals who do not hold academic research positions, health system staff, PWLE, community members, policymakers, researcher users from ICOs, and research users from industry.

<sup>5</sup> Health Research BC follows BC NIEHR's definitions of Indigenous communities and organizations (ICO). BC NIEHR defines ICO as First Nation and Métis chartered community or registered non-profit organization. It is expected that a researcher associated with an Indigenous community or organization will be part of that ICO in some way.

### Additional information on who can apply

Postdoctoral fellows, clinical research fellows and research associates may apply as a primary applicant; however, they must have all necessary approvals to hold the research funds per their host institution's policy.

You may list additional researchers and research users who will be involved in the application form if you wish. Health Research BC encourages the inclusion of PWLE, community members, and trainees<sup>6</sup>, where feasible and appropriate.

Individuals can serve as the primary applicant on only one application and may be designated as a co-lead on up to one other application. Duplicate applications will be removed from the competition.

Health Research BC policies for Government of BC employees and Health Research BC Employees apply.<sup>7</sup> To receive funding, you must have submitted all outstanding reporting information (e.g. final report) requested by Health Research BC for previous awards. Health Research BC reserves the right to declare applications ineligible.

## 4. Health Research BC Priority Themes

The gap, challenge, or opportunity that is the focus of events/activities must be related to at least one of Health Research BC's four priority themes:

- **Population aging**
  - Understanding the causes of, preventing, treating, and palliating conditions associated with aging and older adults; and
  - Identifying and understanding the social determinants and support systems that promote healthy aging and quality of life of older adults in BC.
  
- **Climate change and health**
  - Understanding, mitigating, or preventing:
    - the effects of climate change on the health of people in British Columbia;

<sup>6</sup> Trainees may be undergraduate or graduate students, postdoctoral or clinical research fellows, or equivalent, engaged in a formal training or education program. Trainees may also be individuals employed in the health system who wish to develop their engagement skills.

<sup>7</sup> Government of British Columbia employees (individuals directly employed by provincial ministries) are not eligible to apply but may be named in an application. Employees of organizations funded directly by the Government of British Columbia, such as health authorities or school districts, are eligible to apply. Health Research BC employees are not eligible to apply and must not be named in an application. Potential applicants and team members who may be impacted by this policy should contact Research Competitions at [impactpathways@healthresearchbc.ca](mailto:impactpathways@healthresearchbc.ca) to clarify their eligibility prior to completing the application form.

- the impacts of climate change on BC's health system; and
- the impacts of BC's health system on climate change and the environment.
- **Health human resources challenges**
  - Understanding, mitigating, or addressing the health human resources challenges in BC's health system.
- **Public health emergencies**
  - BC's ability to effectively prevent, prepare for, mitigate, respond to, and recover from public health emergencies; and
  - Health, social, economic, and environmental interventions that increase the resilience of people and communities in BC during public health emergencies.

Applicants must describe how their event/activity aligns with at least one of these themes. Applications will undergo relevance review for alignment with the priority themes (see [Eligibility and Review Process](#)).

### Instructions

#### 1. Set up your ApplyNet account and/or Log In

- **First-time applicants:** Applications must be completed on [Health Research BC ApplyNet](#), our grants management system. If you are applying to Health Research BC for the first time, you must create a system account email and password. Setting up a new account should take approximately 20 minutes.
- **Returning applicants:** Sign in to your [ApplyNet](#) account to access the application form.

#### 2. Open an Application and Complete the Eligibility Quiz

From the ApplyNet home page, click “Apply” in the top left corner of the page. In the Open Competitions table, scroll down and click on the Engage competition to see award information and to launch the eligibility quiz. Successful completion of the eligibility quiz will open the

application form. Opening the application form and completing the eligibility quiz should take no more than 10 minutes.

### 3. Complete Your Application Form

We recommend that applicants review the [Eligibility Check and Review Process](#) and [Funding Decisions](#) before completing the application form. The estimated time required to complete the application form is three hours.

The online application form includes:

- applicant profile
- Primary Applicant and Co-Lead details
- event/activity information
- budget (for assistance in completing your budget see [Allowable Expenses and Example Budget](#) )

Please check your application PDF before you submit, as you won't be able to make changes afterward. Ensure everything is finished by the deadline; incomplete or late applications are not accepted. You will get a final copy of your submission by email.

### 4. Host Institution Approvals and the Review Process

Once you submit your application, it will automatically be forwarded to your host institution for approval. No further action is required on your part. Following host institution approval, your application will undergo the [Eligibility Check and Review Process](#).

### 5. Notice of Decisions and Acceptance

You will be notified by email about the competition results. Successful applicants will receive an award recipient guide for the award acceptance process. Award funds will be administered by your host institution and will be transferred to an account at your host institution by the funding start date. (See [Funding Decisions](#) and [Reporting Requirements](#) for more details.)

## 6. Eligibility Check and Review Process

### 1. Eligibility Check

Health Research BC staff will check that applications meet competition requirements.

### 2. Relevance Review

Health Research BC staff will perform a relevance review to ensure that the applications are in alignment with (1) the purpose and objectives of the competition, and (2) the Health Research BC's priority themes. Applications that are deemed not to be relevant to above will be removed from the competition.

### 3. Administrative Review

Health Research BC staff will perform an administrative review using the criteria outlined below. Applications will be assessed on a pass/fail basis.

#### Administrative Review Criteria

- The described events/activities align with and address the identified gap, opportunity or challenge.
- The event/activity plan includes a description of the format/structure, venue, participants and anticipated outcomes.
- Applicants must review and agree to comply with the ethical and research policies outlined in [Chapter 9: Research Involving the First Nations, Inuit and Métis Peoples of Canada](#) of the [Tri-Council Policy Statement: Ethical Conduct for Research Involving Humans](#) (2022).
- Applicants must agree to include [EDI considerations](#) as appropriate for the participants and context of their work.
- The budget:
  - aligns with the event/activity plan;
  - is feasible; and
  - adheres to the allowable expenses.

## 7. Funding Decisions

Funding decisions will be made using a **modified lottery** approach. Following administrative review, applications that have received a pass assessment will be entered into the lottery. Applications will be grouped into [five funding pools](#). The number of applications funded in each funding pool will be proportional to the number of applications received in each pool.

If you are successful, you will receive an email notification with the further instructions on how to accept your award. You must confirm acceptance of the award within the stipulated time. Deferral of the award is **not** permitted and there is no appeal process.

Award funds will be administered by your host institution and transferred to an account at your host institution by the funding start date. Funds may only be spent during the award funding period, from August 1, 2026, to November 30, 2026.

Award recipients will be published on Health Research BC's website.

#### Funding Pools

Following the eligibility check and review process, applications will be placed into one of following funding pools based on the information provided in the application form:

- Fraser Health Authority region
- Interior Health Authority region
- Vancouver Coastal Health Authority region
- Northern Health Authority region
- Island Health Authority region

Regional funding pools will be determined by the host institution of the primary applicant. Health Research BC staff reserve the right to reassign an application should they be deemed to be better aligned with a different funding pool.

## 8. Reporting Requirements

Award recipients must submit a final report describing the outputs and outcomes of their event/activities 30 days after the award end date. Health Research BC will provide reporting information and/or materials for these purposes. Award recipients must also provide a financial statement of expenditures, signed by the award co-leads and an authorized financial officer of the host institution within three months of the award end date. Any unspent funds must be returned to Health Research BC.

Health Research BC reserves the right to contact award recipients up to five years after the award end date to determine the outcomes and/or impacts.

**Note:** Researchers may not apply for any Health Research funding program until all outstanding award information (e.g. final report, financial statement) requested by Health Research BC for previous grants and awards has been received.

## 9. Allowable Expenses and Example Budget

This award will support costs that are reasonably and directly related to the proposed events/activities.

Applicants must provide a budget as part of the online application. Budgets must follow allowable expenses and include a breakdown of estimated costs for the event/activities and justification for the funds being requested (see example budget below). The majority of expenses must be incurred within BC. The total budget must not exceed \$5,000 (not including in-kind or other contributions).

Health Research BC will not support:

- any expenses incurred prior to, or after completion of, the funding period;
- other expenses already funded by another grant (Health Research BC-funded or otherwise).

All expenses are subject to the travel and expenses reimbursement policies of the host institution.

In the event of a conflict between those policies and the guidelines listed below, the host institution's policy takes precedence. If you have questions about whether an expense is allowable, please contact Research Competitions at [impactpathways@healthresearchbc.ca](mailto:impactpathways@healthresearchbc.ca).

Adjustments to approved budgets are permitted, provided they align with the event or activity scope and follow the allowable expenses policy.

## Allowable Expenses

### Salaries and other supports to enable participation

- Primary applicants may request buy-out/release time for time spent directly on the proposed event/activities, only if their participation in such activities is not part of their expected job responsibilities. For health system staff this may include buy-out time from administrative or clinical duties.
- Research/health professional trainees and staff may be paid to complete services directly related to and integral to the success of the proposed activities.
- Research users may be compensated for their participation, including:
  - cost of caregiving services (e.g. childcare, elder care)
  - buy-out/release time from work, only if their participation in such activities is not part of their expected job responsibilities.

**Note:** Health Research BC recommends that applicants check with their institutions regarding internal policies that govern compensation to PWLE and ensure that the budgeted expenses can be facilitated. If you experience difficulties related to compensating PWLE partners, and/or would like additional guidance regarding compensation amounts for PWLE and/or other community members, please contact Research Competitions.

- Indigenous community engagement – The [Tri-Council Policy Statement 2 \(Chapter 9 Research Involving the First Nations, Inuit and Métis Peoples of Canada\)](#) recognizes the importance of respecting the cultures and traditions of Indigenous Peoples. To facilitate culturally safe events/activities, allowable expenses may include (but are not limited to):
  - Costs related to Indigenous community mobilization and engagement, including culturally relevant promotional items such as traditional medicines (sage, sweetgrass, traditional tobacco), traditional regalia, feasting, gift giving, cash reimbursements (coordinated and agreed upon by community) for ceremonies, and to compensate community participation; and
  - Contracts and/ consultant fees for knowledge mobilization and communication activities for Indigenous Elders, community members, and Indigenous Knowledge Holders involved in activities related to the Indigenous community.

### Services and Supplies

- Meeting rooms and associated meeting costs (e.g., audio-visual equipment fees, non-alcoholic refreshments and/or meals)
- Costs for the purchase or maintenance of equipment required to bring people together (e.g., tablets, cell phones)
- Direct costs associated with bringing people together (e.g., teleconference call, internet conferencing).
- Office costs including supplies, communications, stationery, photocopying, software and network or internet access directly related to the proposed work.

### Travel

- Travel and accommodation to attend the proposed events/activities.

### Non-Allowable Expenses

- The primary applicant and co-lead may not receive a salary or buy-out/release time for activities that fall within their normal work, teaching, clinical or administrative duties. Buy-out or release time may be requested only for time spent on proposed project activities that are not part of their expected job duties.

### Example Budget

If you have received additional cash or in-kind support from other sources (e.g., in-kind or cash contribution from partners/others), please include it in the budget table.

## 10. Additional Considerations for Funded Projects

In addition to the program requirements described above, Health Research BC expects all funded projects to reflect the principles outlined in the sections below. These principles are integral to how we support relationship building, knowledge use, and responsible research across British Columbia and should be considered when designing and delivering proposed events or activities.

### Knowledge Mobilization

Going forward, Health Research BC will transition to align our terminology with [CIHR's Knowledge Mobilization Strategy and Action Plan](#). This change recognizes the growing momentum across the health research system for greater coherence and coordination in knowledge mobilization, while respecting Health Research BC's long-standing commitment to the principles, practices, and expertise developed through more than a decade of knowledge mobilization leadership in British Columbia.

Knowledge mobilization (KM) is a core component of creating a clear and credible pathway to impact for funded research. KM is the processes and activities that support the ethical, timely, and meaningful use of research-based and experiential knowledge to inform decision-making, policy, practice, and further research. KM recognizes that knowledge moves in multiple directions and is strengthened through relationships, context, and collaboration.

For comprehensive guidelines and resources, refer to the [Knowledge Mobilization at CIHR \(KM Portal\)](#).

*Note: Health Research BC recognizes and values multiple ways of knowing, including Indigenous knowledge systems. Applicants are encouraged to describe how their KM approaches are culturally appropriate, ethically grounded, and aligned with the communities and systems involved.*

### Collaborative Research and Research Co-Production

Health Research BC recognizes that collaborative research approaches strengthen KM by improving the relevance, usefulness, and uptake of research findings. Engaging research users — including people with lived and living experience (PWLE) — throughout the research process can enhance the quality, credibility, and impact of research. Engagement may occur at any stage of the research lifecycle, including priority setting, study design, data interpretation, and the mobilization of findings.

Health Research BC refers to integrated knowledge translation (IKT) as research co-production. Patient-oriented research (POR) and community-based participatory research (CBPR) are examples of research co-production approaches. These approaches recognize that effective KM is context-dependent and that meaningful engagement supports the development of solutions to real-world health and system challenges. The Engage awards will enable research co-production by supporting the development of mutually beneficial relationships and learning between researchers and research users.

When appropriate, awardees must also describe their data management plan in accordance with the First Nations principles of [OCAP®: ownership, control, access and possession](#) and/or Indigenous partnering community / organizational ethical guidelines.

## Use of Generative Artificial Intelligence (AI) in Applications

With the latest advancements and rapid uptake in generative AI (such as ChatGPT) to create content, Health Research BC discourages using generative AI tools in application development. Applications submitted to Health Research BC are expected to be the original concepts and ideas generated by the applicant. Applicants should be aware that the content created using generative AI tools may contain the intellectual property of others, false information, or biases. Applicants must ensure that their applications comply with the [Tri-Agency Framework: Responsible Conduct of Research](#), especially pertaining to research integrity. Using AI tools could also result in original content and ideas being harvested and used without consent or credit.

## Indigenous Health Research

Health Research BC is on a learning journey towards enacting our organizational commitments to Indigenous cultural safety and Indigenous health research, grounded in respect for Indigenous self-determination and awareness of reconciliation as an active and ongoing process. Our organizational commitments to Indigenous cultural safety and Indigenous health

research build on relationships nurtured and work undertaken by the former. Key among these relationships are the BC Network Environment for Indigenous Health Research (BC NEIHR) and the First Nations Health Authority.

We recognize that we are still learning how to respectfully support reconciliation efforts and develop meaningful relationships and partnerships with Indigenous people in British Columbia. Our work continues to be guided by our Indigenous advisors and colleagues, key reports, and other research agencies that are on this important journey.

### **Integrating Equity, Diversity and Inclusion (EDI) Considerations in Research**

Health Research BC envisions a health research system that advances equity by removing barriers to participation; promotes diversity by recognizing the underserved and underrepresented; and enables inclusion by supporting cultural change that ensures all peoples are meaningfully represented.

Health Research BC recognizes that meaningful approaches to support EDI in research and KM will vary depending on the research topic, discipline, audience, etc.
